

Pursuant to Rule 65(a) of the Ohio Rules of Civil Procedure, Plaintiff LeBron James hereby moves this Court to enter a Temporary Restraining Order immediately restraining the Defendants, their officers, agents, servants, employees and/or attorneys from:

- A. Taking or enforcing any action or order based on the January 31, 2003 decision by Clair Muscaro declaring LeBron James ineligible as an amateur athlete, or otherwise restraining, preventing or precluding him from participation in interscholastic athletics for the remainder of the 2002-2003 varsity basketball season and playoffs.
- B. Taking or enforcing any action based on the January 31, 2003 decision by Clair Muscaro that would cause Saint Vincent-Saint Mary to forfeit any varsity game in which LeBron James participates or participated as a member of the varsity basketball team during the 2002-2003 varsity basketball season and playoffs.

LeBron James further moves for a preliminary injunction. This Motion is supported by the Verified Complaint and its supporting exhibits, and by the attached Brief in Support.


