INDICTMENT

THE GRAND JURY CHARGES:

COUNT 1

On or about the January 23, 2001, in the Northern District of Indiana and elsewhere,

GLENN MARTIKEAN,

defendant herein, did cross a State line with the intent of engaging in sexual act with a person
under twelve (12) years of age;

All in violation of Title 18, United States Code, Sections 2241(c).

THE GRAND JURY FURTHER CHARGES:

COUNT 2

On or about the January 23, 2001, in the Northern District of Indiana and elsewhere,

GLENN MARTIKEAN,

defendant herein, a United States citizen, did travel foreign commerce to wit: Moscow, Russia.
for the purpose of engaging in a sexual act with a person under the age of eighteen (18);

All in violation of Title 18, United States Code, Sections 2423(b).

THE GRAND JURY FURTHER CHARGES:

COUNT 3

From in or about December 2000, and continuing through on or about January 2001, in the Northern District of Indiana,

GLENN MARTIKEAN,

defendant herein, did knowingly receive visual depictions, specifically, computer photographic --images, that had been mailed, shipped and transported in interstate commerce, such visual depictions being of minors engaged in sexually explicit conduct, specifically, oral-genital sexual intercourse, and anal-genital sexual intercourse, and the lascivious exhibition of the genitals and pubic area of said minors, the producing of such visual depictions involving the use of minors engaged in sexually explicit conduct, and such visual depictions being of such conduct;

All in violation of Title 18, United States Code, Sections 2252(a)(2) and 2.

THE GRAND JURY FURTHER CHARGES:

COUNT 4

From in or about December 2000, and continuing through on or about January 2001, in the Northern District of Indiana,

GLENN MARTIKEAN,

defendant herein, did knowingly distribute visual depictions, specifically, computer photographic images, that had been mailed, shipped and transported in interstate commerce, such visual depictions being of minors engaged in sexually explicit conduct, specifically, oral-genital sexual intercourse, anal-genital sexual intercourse, and the lascivious exhibition of the genitals and pubic area of said minors, the producing of such visual depictions involving the use of minors engaged in sexually explicit conduct, and such visual depictions being of such conduct:

All in violation of Title 18, United States Code, Sections 2252(a)(2) and 2.

THE GRAND JURY FURTHER CHARGES:

COUNT 1

From in or about December 2000, and continuing through on or about January 2001, in the Northern District of Indiana,

GLENN MARTIKEAN,

defendant herein, did knowingly possess with the intent to sell, visual depictions specifically, computer photographic images, that had been mailed, shipped and transported in interstate commerce, and which were produced using materials which had been mailed and so shipped and transported, such visual depictions being of minors engaged in sexually explicitly conduct, specifically, oral-genital sexual intercourse, anal-genital sexual intercourse, and the lascivious exhibition of the genitals and pubic area of said minors, the producing of such visual depictions involving the use of minors engaged in sexually explicit conduct, and such visual depictions being of such conduct;

All in violation of Title 18, United States Code, Sections 2252(a)(3)(B) and 2.

THE GRAND JURY FURTHER CHARGES:

COUNT 6

Between on or about July 4, 1986 through July 7, 1986, in the Northern District of
Indiana and elsewhere.

GLENN MARTIKEAN,

defendant herein, did cross a State line with the intent of engaging in sexual act with a person
under twelve (12) years of age;

All in violation of Title 18, United States Code, Sections 2241(c).

SEXUAL EXPLOITATION FORFEITURE ALLEGATIONS

1. The allegations of Counts two (2) through five (5) of Indictment, are realleged and by this reference fully incorporated herein for the purpose of alleging forfeitures to the United States of America pursuant to the provisions of Title 18, United States Code, Section 2253.

2. As a result of the offenses alleged in Counts two (2) through five (5) of the Indictment, GLENN MARITKEAN shall forfeit to the United States of America all property, real and personal, use or intended to be used to commit or to promote the commission of such offenses involved in the afore stated offense, including, but not limited to:


1. One (1) custom made computer, CPU and all its interior components, bearing no exterior serial number, but having interior hard drives bearing serial numbers K60JS0GC & K40BMXFC;
2. Fifty-one (51) 3 inch floppy disks
3. Sixty-four (64) Compact Disk Recordables (CDR's)

All in violation of Title 18, United States Code, Sections 2423, 2252 and 2253.
