**STATEMENT OF PROBABLE CAUSE**

ARREST ON TRAFFIC/NATURAL RESOURCES CITATIONS/CRIMINAL CHARGES/MUNICIPAL ORDINANCES/PUBLIC LOCAL LAWS

THE DEFENDANT HAS BEEN ARRESTED UPON THE FOLLOWING INFORMATION ON COMPLAINT (AND A PLAIN COMPLAINT) AND AFFIRMATIVE STATEMENT OF PROBABLE CAUSE COMPLYING WITH THE OFFENSE CHARGED.

THE CENTRAL COMPLAINT NUMBER IS 021E09254.

ON 13 MAY 2002 AT 1802 HOURS P/O T. PARRIS 1034 RESPONDED TO THE 700 BLOCK OF RESERVOIR ST. FOR A REPORT OF A SHOOTING. UPON HIS ARRIVAL HE OBSERVED A B/M LATER IDENTIFIED AS MR. MAUNICE BLACKWELL M/B 2/26/44 SUFFERING FROM SEVERAL APPARENT GUNSHOT WOUNDS. MR. BLACKWELL WAS LYING ON HIS SIDE NEXT TO HIS VEHICLE (2000 TOYOTA RAV4 BEARING MD VANTY TAG "PRIEST"). AT THAT TIME P/O PARRIS SECURED THE CRIME SCENE AND CALLED FOR AN AMBULANCE TO RESPOND. MEDIC 4 ARRIVED AND TRANSPORTED VICTIM TO SHOCK TRAUMA. THE VICTIM WAS TREATED FOR GUNSHOT WOUNDS TO HIS LEFT HAND, AND 2 TO HIS LEFT SIDE AREA NEAR THE HIP AND WAS LISTED IN SERIOUS BUT STABLE CONDITION BY DR. SCALIA. SEVERAL PATROL UNITS ARRIVED TO LOCATE WITNESSES AND OBTAIN SUSPECT INFORMATION. WHILE THE VICTIM WAS INSIDE OF THE AMBULANCE, DET. ROBAR WAS ABLE TO SPEAK TO SAME WHO STATED THAT AN INDIVIDUAL HE KNOWS AS DONTÉE STOKES SHOT HIM. MR. BLACKWELL STATED THAT MR. STOKES WAS IN HIS MID TWENTIES AND LIVED ON [REDACTED] AT AN UNKNOWN ADDRESS. SEVERAL WITNESSES WERE LOCATED AND TRANSPORTED TO C.D. TO BE INTERVIEWED. CRIME LAB UNIT 5826 TECH HAVRILLA RESPONDED AND PROCESSED THE CRIME SCENE WHICH CONSISTED OF 1 BULLET FRAGMENT, MR. BLACKWELL'S VEHICLE WHICH TOWED TO HEADQUARTERS TO BE PROCESSED, PAINT CHIPPINGS, AND VARIOUS CLOTHING ITEMS.

DET. ROBAR RESPONDED TO THE 700 BLOCK OF RESERVOIR ST. ALONG WITH DET. LT

ARREST ON TRAFFIC/NATURAL RESOURCES CITATIONS/  
CRIMINAL CHARGES/MUNICIPAL ORDINANCES/PUBLIC LOCAL LAWS

BLOODSWORTH, DET. MONTGOMERY, DET. KLINE, DET. SCHULER OF THE C.D./CID, DET. ROBAR ASSUMED CONTROL OF THE INVESTIGATION. DET. ROBAR WAS ABLE TO INTERVIEW MR. ANTHONY WORKMAN M/B 10-15-53 AT THE CENTRAL DISTRICT. MR. WORKMAN STATED THAT HE WAS TALKING TO THE VICTIM MR. BLACKWELL IN THE 700 BLOCK OF RESERVOIR ST. WHEN A BURGUNDY VEHICLE PULLED UP AND THE DRIVER THE ONLY OCCUPANT BEGAN TO SPEAK WITH MR. BLACKWELL. MR. WORKMAN STATED HE TURNED TO WALK AWAY WHEN HE HEARD 3 GUNSHOTS. AT THAT TIME HE TURNED AROUND AND BEEN THE BURGUNDY VEHICLE DRIVING OFF WEST BOUND ON RESERVOIR AND MR. BLACKWELL LAYING ON THE GROUND SUFFERING FROM APPARENT GUNSHOT WOUNDS. MR. WORKMAN WAS SHOWN A PHOTO LINEUP CONTAINING SIX INDIVIDUALS SIMILAR IN APPEARANCE AND MR. WORKMAN WAS ABLE TO POSITIVELY IDENTIFY A PHOTOGRAPH CONTAINING THE SID #2262034 AS THE INDIVIDUAL WHO WAS ALONE IN THE BURGUNDY VEHICLE AND SPEAKING TO MR. BLACKWELL SECONDS BEFORE HE HEARD THE GUNSHOTS. SID #2262034 BELONGS TO MR. DONTÉE STOKES M/B 2/9/16.

ALSO INTERVIEWED WAS MR. TIMOTHY MCLAURIN JR. M/B 5/5/74 WHO STATED THAT HE OBSERVED AN INDIVIDUAL WHO HE KNOWS A DONTÉE STOKES DRIVE PAST THE 700 BLOCK OF RESERVOIR ST. MR. STOKES WAS OPERATING A BURGUNDY VEHICLE WITH THE PARTIAL TAG OF 3033 ACCORDING TO MR. MCLAURIN. AFTER SEEING MR. STOKES DRIVE PAST MR. MCLAURIN WENT BACK INSIDE OF [REDACTED] AT THAT TIME HE HEARD 3 GUNSHOTS AND RAN BACK OUTSIDE. MR. MCLAURIN OBSERVED THE BURGUNDY VEHICLE THAT WAS DRIVEN BY MR. STOKES MOMENTS EARLIER DRIVE WEST BOUND ON RESERVOIR ST. MR. MCLAURIN ALSO STATED THAT HE OBSERVED MR. BLACKWELL LAYING ON THE GROUND SUFFERING FROM SEVERAL GUNSHOT WOUNDS. MR. MCLAURIN WAS ALSO SHOWN A PHOTO LINEUP CONTAINING SIX INDIVIDUALS SIMILAR IN APPEARANCE AND AT THAT TIME MR. MCLAURIN IDENTIFIED THE PHOTO WITH THE SID # 2262034 AS THE INDIVIDUAL HE HAD SEEN DRIVE THE BURGUNDY VEHICLE. MR. MCLAURIN STATED THAT THE INDIVIDUAL HE PICKED OUT IS A MR. DONTÉE STOKES. THE VICTIM STATED TO MR. MCLAURIN WHILE HE WAS LAYING ON THE GROUND PRIOR TO THE MEDICS ARRIVAL THAT DONTÉE STOKES IS THE PERSON WHO SHOT HIM.

ON 13 MAY 2002 AT APPROX 2345 HOURS DET. ROBAR RECEIVED A CALL FROM DET. SMITH OF NWD/CID WHO STATED THAT HE HAD AN INDIVIDUAL IN CUSTODY WHO STATED THAT THEY HAD JUST SHOT SOMEONE ON RESERVOIR HILL. THE INDIVIDUAL IDENTIFIED HIMSELF AS MR. DONTÉE STOKES. AT THAT TIME MR. STOKES WAS TRANSPORTED TO C.D./CID OFFICE. MR STOKES KNOWINGLY AND VOLUNTARILY WAIVED HIS RIGHTS AND GAVE THE FOLLOWING TAPED STATEMENT. MR. STOKES STATES HE WAS ABUSED BY THE VICTIM MR. BLACKWELL SEVERAL YEARS AGO MR. STOKES STATED THAT HE LEFT HIS HOME AT [REDACTED] WITH A .357 SMITH AND WESSON HANDGUN. AT THAT TIME HE PLACED THE HANDGUN IN A BLACK DUffel BAG AND BEGAN TO DRIVE HIS GIRLFRIENDS VEHICLE THROUGH THE 700 BLOCK OF RESERVOIR ST. ON HIS WAY TO MEET HIS GIRLFRIEND AT LUNCH. AT THAT TIME HE OBSERVED THE VICTIM IN THE BLOCK BUT CONTINUED TO DRIVE PAST HIM. MR. STOKES STATED THAT HE CAME BACK AROUND THE BLOCK AND STOPPED THE VEHICLE TO TALK TO MR. BLACKWELL. AT THAT TIME MR. BLACKWELL DID NOT SHOW ANY INTEREST IN SPEAKING WITH VICTIM AND AFTER SEVERAL ATTEMPTS MR. STOKES STATES THAT HE DOESN'T KNOW WHAT CAME OVER HIM. MR.

## STATEMENT OF PROBABLE CAUSE

ARREST ON TRAFFIC/NATURAL RESOURCES CITATIONS/  
CRIMINAL CHARGES/MUNICIPAL ORDINANCES/PUBLIC LOCAL LAWS

STOKES THEN STATED HE REMOVED THE HANDGUN HE WAS CARRYING FROM THE BLACK BAG AND HOLSTER IT WAS IN AND FIRED 3 SHOTS OUT OF HIS PASSENGER WINDOW OF HIS VEHICLE AT THE VICTIM. MR. STOKES STATED THAT HE THEN DROVE OFF. MR. STOKES STATED THAT HE LEFT THE VEHICLE AT SINAI HOSPITAL AND WALKED DOWN GREENSPRING AVENUE. WHEN THE VICTIM REACHED 4818 GREENSPRING A VACANT DWELLING HE PLACED THE BLACK DUFFEL BAG CONTAINING THE HANDGUN AND AMMUNITION INSIDE OF A LARGE TREE. MR. STOKES AGREE TO ESCORT DET. ROBAR AND DET. MONTGOMERY TO THE LOCATION. MR. STOKES THEN POINTED TO DET. ROBAR THE TREE AND J WAS ABLE TO LOCATE A BLACK BAG INSIDE THE TRUNK OF THE TREE. THE AREA WAS SECURED AND CRIME LAB 5011 TECH PIERRE-PHILLIPE RESPONDED AND PHOTOGRAPHED THE SCENE. CRIME LAB ALSO RECOVERED THE DUFFEL BAG WHICH CONTAINED 1 SMITH AND WESSON .357 FIREARM WITH 3 EMPTY CASINGS AND 3 LIVE ROUNDS INSIDE OF SAME. ALSO RECOVERED FROM THE BLACK DUFFEL BAG WAS A SPEED LOADER CONTAINING FIVE LIVE ROUNDS. ALL EVIDENCE WAS RECOVERED BY CRIME LAB AND SUBMITTED TO ECU.

DONTAE STOKES WAS TRANSPORTED TO CRIF TO BE CHARGED ACCORDINGLY.
